- ✓ Discount percentages above reflect the approximate amount deducted from GFH's full charge for a particular service.
- ✓ *Office Visits of a limited scale/scope will be assessed half of the above-indicated deposit amount.
- ✓ **Laboratory, hospital care, imaging and/or other ancillary services performed by a non-GFH provider will be billed separately by that provider. GFH's Sliding Fee Discount Program does not apply to services provided by non-GFH providers; financial assistance must be discussed directly with the rendering provider.
- ✓ Required supplies such as vaccines, injectable medications, birth control devices, etc., will be charged separately in addition to the Office Visit deposit or Procedure charge. Patients at 200% or below of the Federal Poverty Guidelines will receive a 50% discount off GFH's full charge for these items.
- ✓ Costs for any additional services and/or supplies recommended by your GFH provider will be discussed before the service is performed and/or the supplies utilized. Payment plans can be arranged during any part of your patient experience! Please address any questions about the cost of your care with a GFH staff member.
